Η 13η Συνάντηση της Επιτροπής Καθοδήγησης (Steering Group) των Ευρωπαϊκών Δικτύων Αγροτικής Ανάπτυξης πραγματοποιήθηκε στις 26 Μαΐου 2020 μέσω webinar. Στη συνάντηση συμμετείχαν διαδικτυακά 74 συμμετέχοντες από 27 κράτη μέλη, εκπρόσωποι των Μονάδων Υποστήριξης των Εθνικών Αγροτικών Δικτύων, εκπρόσωποι των Διαχειριστικών Αρχών, εκπρόσωποι ευρωπαϊκών οργανισμών αγροτικής ανάπτυξης, εκπρόσωποι της Ευρωπαϊκής Επιτροπής, στελέχη του Ευρωπαϊκού Δικτύου Αγροτικής Ανάπτυξης (ENRD), συμπεριλαμβανομένου και του Evaluation Help Desk και του Δικτύου Ευρωπαϊκής Σύμπραξης Καινοτομίας για τη Γεωργία (ΕΙΡ AGRI). Από την ΕΥΔ ΠΑΑ συμμετείχαν η Μαρία – Χριστίνα Μακρανδρέου από τη Μονάδα Δικτύωσης & Δημοσιότητας.

Τα κύρια θέματα της συνάντησης αφορούσαν:

- Ενημέρωση σχετικά με την πορεία της μεταρρύθμισης της ΚΑΠ και άλλων σχετικών πρωτοβουλιών της Ευρωπαϊκής Ένωσης, συμπεριλαμβανομένου του COVID19 για τον αγροδιατροφικό τομέα και τις αγροτικές περιοχές.
- Παρουσίαση των πρόσφατων και προγραμματισμένων δραστηριοτήτων των Ευρωπαϊκών Δικτύων Αγροτικής Ανάπτυξης.
- Ανταλλαγή απόψεων για τις δραστηριότητες που προγραμματίζονται για την περίοδο 2020-2021 στο πλαίσιο λειτουργίας του Ευρωπαϊκού Δικτύου Αγροτικής Ανάπτυξης.
- Υποβολή προτάσεων για την επόμενη συνάντηση της Ομάδας καθοδήγησης και της Ολομέλειας.

Ο Πρόεδρος της συνάντησης και Διευθυντής της DG AGRI κος Mario Milouchev πραγματοποίησε μία σύντομη αναφορά στα συμπεράσματα της προηγούμενης συνάντησης και στα θέματα της ημερήσιας διάταξης. Τόνισε την αναγκαιότητα να εξασφαλισθεί η συνέχεια των δραστηριοτήτων του Ευρωπαϊκού Δικτύου Αγροτικής Ανάπτυξης κατά τη μεταβατική περίοδο προκειμένου, μέσω των δραστηριοτήτων του, να παρέχει στήριξη για την προετοιμασία των Στρατηγικών Σχεδίων ΚΑΠ στα κράτη μέλη, καθώς και το ρόλο που θα διαδραματίσει το επόμενο διάσημα για την προετοιμασία της Ανακοίνωσης της Επιτροπής σχετικά με το «Μέλλον των αγροτικών περιοχών».

Η κα Silvia Michelini, στέλεχος της DG AGRI, στην παρουσίασή της, έκανε μία ανασκόπηση στις πρόσφατες πρωτοβουλίες που έχει αναλάβει η Ευρωπαϊκή Επιτροπή λόγω του COVID-19 καθώς και στο πλαίσιο προετοιμασίας της μεταρρύθμισης της ΚΑΠ. Συγκεκριμένα αναφέρθηκε:


• Στις νέες πρωτοβουλίες και μέτρα της Επιτροπής για την αντιμετώπιση των προβλημάτων που έχουν δημιουργηθεί λόγω της πανδημίας: νέο Μέτρο ΠΑΑ, ευελιξία στα χρηματοδοτικά





εργαλεία, δυνατότητα μεγαλύτερων προκαταβολών, μεγαλύτερο ύψος κρατικών ενισχύσεων για αγρότες και μεταποιητικές επιχειρήσεις, μέτρα ευελιξίας στον Πυλώνα Ι.

- Στη δημοσίευση των δύο στρατηγικών «Farm to Fork» και «Βιοποικιλότητα» στο πλαίσιο της Πράσινης Συμφωνίας.
- Στην πρωτοβουλία των Επιτροπών Γεωργίας & Αγροτικής Ανάπτυξης Janusz Wojciechowski,
   Συνοχής & Μεταρρυθμίσεων Elisa Ferreira και της Αντιπροέδρου για τη Δημοκρατία και Δημογραφία Dubravka Šuica, να καταρτιστεί ένα μακροπρόθεσμο όραμα για τις αγροτικές περιοχές, για την οποία προγραμματίζεται δημόσια διαβούλευση τον Σεπτέμβριο του 2020 και δημοσίευση της Ανακοίνωσης της Επιτροπής το πρώτο εξάμηνο του 2021.
- Στην πορεία των διαπραγματεύσεων για την ΚΑΠ 2021-2027 και τον μεταβατικό κανονισμό, καθώς και στην πορεία προετοιμασίας των Στρατηγικών Σχεδίων ΚΑΠ.







Ο David Lamb <u>παρουσίασε</u> αντίστοιχα τις πρόσφατες και προγραμματισμένες δραστηριότητες του Ευρωπαϊκού Δικτύου Αγροτικής Ανάπτυξης (ENRD) οι οποίες όλες προς το παρόν διεξάγονται μέσω Webinar, ενώ αναφέρθηκε στη δημιουργία ειδικής ενότητας στο site του ENRD <a href="https://enrd.ec.europa.eu/rural-responses-covid-19-crisis en">https://enrd.ec.europa.eu/rural-responses-covid-19-crisis en</a> όπου παρουσιάζονται παραδείγματα, από όλα τα κράτη μέλη, αλληλεγγύης και καλών πρακτικών για την αντιμετώπιση των δυσκολιών στις αγροτικές περιοχές που προκλήθηκαν από την πανδημία του COVID19..

Τέλος, ο **John Grieve** από το Ευρωπαϊκό δίκτυο Αγροτικής Ανάπτυξης (ENRD) παρουσίασε **Σχέδιο του Προγράμματος Δραστηριοτήτων του ENRD για το 7° έτος λειτουργίας του**, δηλ. για την περίοδο 2020-2021. Οι δραστηριότητες κατανέμονται σε 6 Πακέτα ενεργειών και συγκεκριμένα:

- **P1: Στήριξη για αποτελεσματικότερη και απλούστερη υλοποίηση των προγραμμάτων:** αφορά κυρίως ενέργειας για την προετοιμασία των Στρατηγικών Σχεδίων ΚΑΠ και την ανάκαμψη των αγροτικών περιοχών από τον COVID-19.
- **P2: Στήριξη των ΕΑΔ και των Μονάδων Υποστήριξης των ΕΑΔ:** αφορά κυρίως ενέργειες για την ενδυνάμωση των δικτύων, τη συμμετοχή περισσότερων φορέων, την προετοιμασία για τα ΚΑΠ Δίκτυα, τη χρήση μεθόδων για αποτελεσματικότερες διαβουλεύσεις.





#### P3: Στήριξη του LEADER

**P4:** Δημιουργία Θεματικής Ομάδας «#Αγροτικές περιοχές 2040» (Long-Term Vision for Rural Areas/LTVRA) η οποία αφορά στην προετοιμασία της διαβούλευσης για τη νέα Ανακοίνωση της Ευρωπαϊκής Επιτροπής σχετικά με το μέλλον των αγροτικών περιοχών.

#### P5: Δημιουργία Θεματικής Ομάδας «Πράσινη συμφωνία και αγροτικές περιοχές»

Καθώς και ένα **έκτο πακέτο εργασιών οριζόντιου χαρακτήρα** που αφορά στη λειτουργία του site, στην ανάδειξη καλών πρακτικών, στην ανάλυση των ΠΑΑ, στη χρήση μέσων κοινωνικής δικτύωσης, και στην παραγωγή εκδόσεων.



Λόγω της περιορισμένης διάρκειας της τηλε-συνάντησης δεν υπήρξε χρόνος για περαιτέρω ανταλλαγή απόψεων των συμμετεχόντων όπως είθισται κατά τη διάρκεια των δια ζώσης συναντήσεων.
